#1 - I'd like to thank you and Arizona's Legislature for the recent bipartisan budget agreement that adds **\$50 million** for **Arizona COVID-19** response.

#2 - Also, kudos for the recently announced **\$5.3 Million** For Meals For **Arizona Seniors**.

#3 - And now, more than ever, the **over 1 Million Arizonans in NEED** (Living in POVERTY, Low-Income, Seniors, Disabled, Homeless) **NEED YOUR HELP!**
