PPX[®]'s unique **CONTACTLESS & USPS SECURE ARIZONA TAX-FREE MONEY[®]** PROGRAM FOR **ARIZONANS IN NEED** was developed by **Dennis Melin**, President & Treasurer, starting in June, 2015 & since then **PPX[®]** has helped hundreds of **ARIZONANS IN NEED** **annually CLAIM & RECEIVE** their share of the **Hundreds of Millions of Dollars** being held in Arizona for their benefit!
