**Receive up to \$527 or \$602 annually - file *little-known* Arizona Form 140PTC by April 15<sup>th</sup> (NOTE: April 15<sup>th</sup>, 2020 deadline extended 3 months to July 15<sup>th</sup>, 2020) if you answer YES to each of the following 5 questions:**

1. On last December 31<sup>st</sup>, did you pay rent to someone who paid Property Taxes or did you own your own home and pay Property Taxes? **YES** [ ]
2. Were you an Arizona resident for all of last year? **YES** [ ]
3. Is this the only Property Tax Refund being claimed this year? **YES** [ ]
4. Last year, were you age 65 or older or did you receive Title 16, SSI payments? **YES** [ ]
5. If you live alone, was your Taxable Income (excluding Social Security or Railroad Retirement Benefits) less than \$3,751 last year or if you live with your spouse or another person, was your household Taxable Income (excluding Social Security or Railroad Retirement Benefits) less than \$5,501 last year? **YES** [ ]

**Receive \$25 or up to \$100 annually - file *little-known* Arizona Form 140ET by December 31<sup>st</sup> if you answer TRUE to each of the following 6 statements:**

1. I have a Social Security Number (SSN) that is valid for employment. **TRUE** [ ]
2. I am not required to file an income tax return for last year and I do not qualify for the Property Tax Credit on Arizona Form 140PTC for last year. **TRUE** [ ]
3. I was an Arizona resident during last year. **TRUE** [ ]
4. I was not claimed as a dependent by any other taxpayer for last year. **TRUE** [ ]
5. I was not sentenced for at least 60 days of last year to a county, state, or federal prison. **TRUE** [ ]
6. My federal adjusted gross income (excluding Social Security or Railroad Retirement Benefits) for last year was \$25,000 or less if married filing a joint claim or as head of household or \$12,500 or less otherwise. **TRUE** [ ]

**NOTE:** You can file **Arizona Form 140ET** by **December 31<sup>st</sup>** for each of the prior **4 years** that you qualify for.
