Every **Arizonan in NEED** Family can **annually** CLAIM & RECEIVE up to **\$602** or up to **\$100**, respectively, in “**CONTACTLESS & USPS SECURE**” **Arizona Tax-FREE Money**® checks (or direct deposits) ... and that’s **EVERY YEAR!**

1. On last December 31<sup>st</sup>, did you pay rent to someone who paid Property Taxes or did you own your own home and pay Property Taxes? **YES** [ ]
2. Were you an Arizona resident for all of last year? **YES** [ ]
3. Is this the only Property Tax Refund being claimed this year? **YES** [ ]
4. Last year, were you age 65 or older or did you receive Title 16, SSI payments? **YES** [ ]
5. If you live alone, was your Taxable Income (excluding Social Security or Railroad Retirement Benefits) less than \$3,751 last year or if you live with your spouse or another person, was your household Taxable Income (excluding Social Security or Railroad Retirement Benefits) less than \$5,501 last year? **YES** [ ]

**Notes:**

1. Only **7,356** 140PTC “**CLAIM Forms**” were filed by the over **1 Million Arizonans in NEED** in fy 2019.
2. The **April 15<sup>th</sup>, 2020 filing deadline** has been **extended** 3 months to **July 15<sup>th</sup>, 2020** because of the COVID-19 pandemic.

**Receive up to \$100 annually by filing the *little-known* Arizona Form 140ET by December 31<sup>st</sup> if you answer TRUE to each of the following 6 statements:**

1. I have a Social Security Number (SSN) that is valid for employment. **TRUE** [ ]
2. I am not required to file an income tax return for last year and I do not qualify for the Property Tax Credit on Arizona Form 140PTC for last year. **TRUE** [ ]
3. I was an Arizona resident during last year. **TRUE** [ ]
4. I was not claimed as a dependent by any other taxpayer for last year. **TRUE** [ ]
5. I was not sentenced for at least 60 days of last year to a county, state, or federal prison. **TRUE** [ ]

6. My federal adjusted gross income (excluding Social Security or Railroad Retirement Benefits) for last year was \$25,000 or less if married filing a joint claim or as head of household or \$12,500 or less otherwise. TRUE [ ]

**Notes:**

1. Only **1,425** 140ET “CLAIM Forms” were filed by the over **1 Million Arizonans in NEED** in fy 2019.
2. Arizona Form 140ET can be filed by **December 31<sup>st</sup>** for each of the prior 4 years that you qualify for.

Additionally, each **Arizona County Assessor** has 3 *little-known* Residential Property Assessment Assistance programs for **Arizonans in NEED** under Arizona’s A.R.S., its Constitution, & 2000 Proposition 104 & 2012 Proposition 117, and **Arizona Utilities** and **Phone Companies** have *little-known* Rate Reduction programs for **Arizonans in NEED**.
